01. Sealed tenders are hereby invited by The Chairman of The Associated Newspapers of Ceylon Ltd from Manufacturers, Representatives or their Accredited Local Agents or Local suppliers for the supply of 6000MT First Class Web Offset Newsprint conforming to the specifications attached herewith (Annexure II)

02. FORM OF TENDER

- 2:1 Tenders should be submitted in duplicate (marked "Original and Duplicate") only on Tender Documents available at Imports Department of the Associated Newspapers of Ceylon Ltd on payment of non-refundable fee of Rs. 5,000.00 in cash.
- 2:2 Tender Documents will be issued during office hours until 29th May 2006.
- 2:3 Tender Documents are also available at the Website www.dailynews.lk or www.sundayobserver.lk and could be used with the payment of non-refundable fee of Rs. 5,000.00.
- 2:4 Separate Tender documents should be used for each offer

03. CLOSING DATE OF TENDER

- 3:1 Tender shall be marked "**TENDER FOR THE SUPPLY OF WEB OFFSET NEWSPRINT**" on top left hand corner of the envelope and submit by registered cover addressed to the **Chairman, Tender Board, The Associated Newspapers of Ceylon Limited, Lake House, 35, D.R. Wijewardena Mawatha, Colombo 10** or be deposited in the **Tender Box** kept for this purpose at the Imports Dept. of the Associated Newspapers of Ceylon Limited on or before the date and time as mentioned in paragraph 3:2 of this instructions. **Tenders received after the closing time will be rejected.**

- 3:2 **Tender will be closed at 2.00 p.m. on 30th May 2006 and will be opened immediately after the closing time.** Tenderers or one of their accredited agents will be allowed to be present at the opening of tenders on the date and time of the place specified in this clause.

04. ELIGIBILITY TO TENDER

- 4:1 Manufacturers / Principals or their Accredited Local Agents or Local Suppliers are eligible to tender.
- 4:2 No local tender on behalf of foreign principals will be considered unless the tender holds an executed Power of Attorney from the manufacturers/Principals to enter into a valid agreement to fulfil all the terms and conditions of the contract in the event of it being awarded.
- 4:3 **Offers from new tenderers** will be considered after testing the quality of the samples.

05. LANGUAGE OF TENDER

All correspondence shall be in English Language.

06. AMENDMENTS TO TENDER DOCUMENTS

No modification or alterations are allowed after the closing of the tenders

07. BUSINESS ADDRESS

Tenderers should state in their tenders, the address to which notices, orders and correspondence relating to the Tenders and Agreements are to be sent. Any change of address should be notified to the Chairman, Tender Board, The Associated Newspapers of Ceylon Limited, Lake House, No.35, D.R. Wijewardene Mawatha, Colombo 10.

08. PERIOD OF VALIDITY

- 8:1 Tenderers are required to keep their prices firm and valid for a minimum period of 60 days from the date of closing of Tender.

09. OFFERS

- 9:1 The Tenderers should quote their C & F Colombo price indicating FOB & Freight Rate separately. The freight invoiced against the shipping invoice should be the actual freight paid indicated in the Bill of Lading or the freight receipt issued by the shipping company. However, the freight paid against the shipping documents will be the actual freight paid or quoted whichever is lower.

9:2 All quotations must be in words and figures and changes, erasures, alterations or amendments should be authenticated by the tenderer's full signature. In the event of any discrepancy between words and figures, the amount given in words shall prevail.

9:3 The offers shall be in the currency of the country of the Tenderers, or in US Dollars or Pounds Sterling or Euros or Japanese Yen only.

9:4 Tenderers should state separately the commission/charges, which will be paid to the local agent in Sri Lanka Rupees on completion of the contract. Local Agent's commission will not be included in the Letter of Credit.

9:5 The Chairman Tender Board, The Associated Newspapers of Ceylon Ltd., reserves the right to reject any or all offers without assigning any reasons whatsoever.

9:6 Any other details.

12. SAMPLES :

Minimum of 20 sheets of A4 size paper or 5 to 10 metre piece of paper in roll form.

13. MODE OF PAYMENT :

Letter of Credit at sight or DP Terms

14. PRE-SHIPMENT INSPECTION CERTIFICATION :

Supplier has to provide on his own expenses. (if required)

15. SHIPMENT will be notified after finalization of orders

16. BID BOND

All offers should be accompanied by a Bid Bond (one offer per one Bid Bond) acceptable to the Tender Board for the value of Rs. 200,000/-. This Bid Bond may be offered in one of the following alternative forms.

- a. A cash deposit
- b. An acceptable Bank Guarantee confirmed by a Bank operating in Sri Lanka payable to The Associated Newspapers of Ceylon Ltd.
- c. An unconditional Bid Bond excusable on demand issued by a reputed Insurance company in Sri Lanka payable to The Associated Newspapers of Ceylon Ltd. The validity of any of the above Guarantee will be at least 120 days from the date at opening of tenders.
- d. If no Bid Bond is submitted the offer will not be considered.

17. PERFORMANCE BOND

- 17:1 The successful Tenderer should provide a Performance Guarantee Bond to the value of 2% (up to 10%) from an approved Bank operating in Sri Lanka.
- 17:2 This Bond should be submitted to the Associated Newspapers of Ceylon Ltd within 01 week of the date the offer is accepted.
- 17:3 This Bond should be valid for a minimum 120 days from the date of awarding of tender and will be released only after satisfactory receipt of goods.
- 17:4 In case of delay or default by the supplier the Associated Newspapers of Ceylon Ltd, shall have the option of terminating the contract and collecting the performance bond without prejudice to any other claims that be lodged in this regard.

18. AGREEMENT

The successful tenderer must enter into an Agreement with The Associated Newspapers of Ceylon Limited within 01 week of the information of the award is made. This agreement should not be assigned or transferred to anyone without the written consent of The Associated Newspapers of Ceylon Limited.

19. ARBITRATION

All disputes arising out of contract agreement will be dealt with accordance with the Provision of Arbitration Act No. 11 of 1995.
